AN ORDINANCE INCORPORATING THAT PROPERTY IN THE KEARNY VISTA COMMUNITY LOCATED WESTERLY OF LINDA VISTA ROAD, ON THE NORTH SIDE OF GENESEE AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 3729 (NEW SERIES), ADOPTED MAY 4, 1948, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.
