

ORDINANCE NO. 11318 MAY 9 1974
(New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE RANCHO BERNARDO AREA LOCATED ON THE NORTH SIDE OF RANCHO BERNARDO ROAD, EASTERLY OF BERNARDO CENTER DRIVE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9442 (NEW SERIES), ADOPTED MAY 26, 1966, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS IT CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Rancho Bernardo Area located on the north side of Rancho Bernardo Road, easterly of Bernardo Center Drive, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. C-409.1, filed in the office of the City Clerk as Document No. 746849, be, and it is hereby incorporated into R-2A Zone as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 9442 (New Series), adopted May 26, 1966, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
