ORDINANCE NO. 11322 MAY 16 1974
(New Series)

AN ORDINANCE INCORPORATING PARCEL B OF LOT 2, SCRIPPS VILLAGE CENTER UNIT 2, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10038 (NEW SERIES), ADOPTED MAY 8, 1969 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcel B of Lot 2, Scripps Village Center Unit 2, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. B-27677 B-2767.1 747819 filed in the office of the City Clerk under Document No. 746077 be, and it is hereby incorporated into R-2A Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10038 (New Series), adopted May 8, 1969, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
