AN ORDINANCE TO EFFECTUATE REZONING OF LOT 9,  
BLOCK 2, DRUCKER'S SUBDIVISION, IN THE CITY  
OF SAN DIEGO, CALIFORNIA, AS PROVIDED IN  
ORDINANCE NO. 11070 (NEW SERIES), ADOPTED  
MAY 24, 1973.

WHEREAS, the City Council adopted Ordinance No. 11070  
(New Series) on May 24, 1973, incorporating certain lands  
into the C-1S Zone on conditions set forth in said ordinance;  
and

WHEREAS, the City Council finds that those conditions  
contained in Ordinance No. 11070 (New Series) relating to  
parcel consolidation are not applicable to Lot 9, Block 2,  
Drucker's Subdivision, designated on Zone Map Drawing  
No. B-2702.1 for inclusion in the C-1S Zone; and

WHEREAS, the City Council finds that the C-1S Zone  
provisions should attach to the said Lot 9, Block 2, Drucker's  
Subdivision, and become effective upon the effective date of  
this ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego,  
as follows:

Section 1. Notwithstanding any provisions of Ordinance  
No. 11070 (New Series) to the contrary, Lot 9, Block 2, Drucker's  
Subdivision, in the City of San Diego, California, designated  
"C-1S" on Zone Map Drawing No. B-2702.1, shall be incorporated  
into C-1S Zone as described and defined by Section 101.0430 of  
the San Diego Municipal Code.

Section 2. That in the event the zoning restrictions shall attach to the land described in Section 1 of this ordinance, Ordinance No. 4407 (New Series), adopted May 16, 1950, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
