AN ORDINANCE PROVIDING ADDITIONAL TIME WITHIN  
WHICH TO PAY SIGN USE PERMIT FEES.

WHEREAS, pursuant to San Diego Municipal Code Section 95.0107, notices for sign use permit fees for existing signs were mailed to businesses on or about May 22, 1974; and

WHEREAS, paragraph C.2. of said section provides that unless the sign permit fee is paid within 30 days of written notice, a fee of twice the normal amount shall be assessed; and

WHEREAS, businesses to which these notices were sent must decide within 30 days whether to retain the signs and pay the permit fee or remove or modify the signs; and

WHEREAS, an unnecessary hardship is caused many businesses by virtue of the short period within which any decision for modification must be made; and

WHEREAS, the period of 60 days from the receipt of the sign permit notice or 30 days after the effective date of this ordinance, whichever occurs later, is a reasonable time within which to pay the required permit fee for existing signs; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Notwithstanding the provisions of Section 95.0107, paragraph C.2., of the San Diego Municipal Code, there shall be no increase in the fee for the initial use permit for

an existing sign for which written notice to obtain such initial permit has been sent by The City of San Diego, so long as such initial permit is obtained within 30 days after the effective date of this ordinance or within 60 days after receipt of said notice, whichever date occurs later.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

later.

Section 2. This ordinance shall  
take effect and be in force on the  
thirtieth day from and after its  
passage.
