AN ORDINANCE PROVIDING FOR APPROPRIATION OF FUNDS FOR REFUSE COLLECTION IN MISSION BEACH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Pursuant to the authority of Section 35.0116(b), an appropriation in the sum of \$5,100 from the Transient Occupancy Unappropriated Reserve Fund (Fund 224) is hereby ordained, solely and exclusively for the purpose of providing refuse collection service on a twice-weekly basis in Mission Beach for a period beginning June 1 and ending September 30 each year.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
