AN ORDINANCE AMENDING ORDINANCE NO. 11331 (NEW SERIES), ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1974-75," BY AMENDING EXHIBIT C THERETO RELATING TO ADDITIONS, DELETIONS AND CHANGES OF POSITION TITLES IN THE EXECUTIVE CATEGORY OF THE UNCLASSIFIED SERVICE.

WHEREAS, on May 29, 1974, the City Council sitting as a Committee of the Whole approved a departmental reorganization as recommended by the City Manager; and


