AN ORDINANCE ESTABLISHING NEW
PARKING METER ZONES.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. Pursuant to the authority of Section 22508
of the California Vehicle Code, and in accordance with the
provisions of Chapter VIII of the San Diego Municipal Code,
parking meter zones are hereby established in the following
locations:

East side of FIRST AVENUE, between
Elm and Fir Streets;

South side of FIR STREET, between
First and Second Avenues;

West side of SECOND AVENUE, between
Fir and Elm Streets; and

North side of ELM STREET, between
First and Second Avenues.

The above-described meters shall be in parking meter Zone A
as described in Section 86.11 of the San Diego Municipal Code.

Section 2. A parking time limit of ^{two}~~one~~ hour shall be
in effect in the above-described locations between the hours
of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays
excepted.

Section 3. The installation of parking meters and
the necessary signs and markings be, and the same are hereby

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
