AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 8 OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 98.16 RELATING TO FEES FOR MOBILEHOME INSTALLATION PERMITS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 8 of the San Diego Municipal Code be and the same is hereby amended by adding Section 98.16 to read as follows:

SEC. 98.16 MOBILEHOME INSTALLATION PERMIT FEES

The fees prescribed in this section must be paid to The City of San Diego for each mobilehome installation for which a permit is required by Title 25, Article 1A, Section 5076 et seq. of the California Administrative Code, and must be paid before any such permit is issued. The fees for a mobilehome installation permit shall be as follows:

- a. Application filing fee, five dollars (\$5);
- b. Installation permit fee, twenty-five dollars (\$25);
- c. Reinspection fee, twenty-five dollars (\$25).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

**SEC. 98.16 MOBILEHOME INSTALLATION PERMIT FEES**

The fees prescribed in this section must be paid to The City of San Diego for each mobilehome installation for which a permit is required by Title 25, Article 1A, Section 2070 et seq. of the California Administrative Code, and must be paid before any such permit is issued. The fees for a mobilehome installation permit shall be as follows:

- a. Application Ring fee, five dollars (\$5);
- b. Installation permit fee, twenty-five dollars (\$25);
- c. Reinspection fee, twenty-five dollars (\$25).

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
