ORDINANCE NO. 11364
(New Series)

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY CONSISTING OF MT. HOPE CEMETERY BOUNDED BY 36TH STREET ON THE WEST, MARKET STREET ON THE NORTH, BOUNDARY STREET (EXTENDED) ON THE EAST, AND IMPERIAL AVENUE ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-40 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13216, APPROVED MAY 18, 1931, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Southeast San Diego Community consisting of Mt. Hope Cemetery bounded by 36th Street on the west, Market Street on the north, Boundary Street (extended) on the east, and Imperial Avenue on the south, in the City of San Diego, California, within the boundary of the district designated "R-1-40" on Zone Map Drawing No. C-405.1, filed in the office of the City Clerk as Document No. 748498, be, and it is hereby incorporated into R-1-40 Zone as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13216, approved May 18, 1931, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
