AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY GENERALLY BOUNDED BY 43RD STREET ON THE WEST, BOSTON AVENUE ON THE NORTH, I-805 ON THE EAST, AND NATIONAL CITY ON THE SOUTH, IN THE CITY OF SAN DIEGO, INTO R-2A AND R-2 ZONES, AS DEFINED BY SECTIONS 101.0410 AND 101.0409, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 78 (NEW SERIES), ADOPTED NOVEMBER 14, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Southeast San Diego Community generally bounded by 43rd Street on the west, Boston Avenue on the north, I-805 on the east, and National City on the south, in the City of San Diego, California, within the boundaries of the districts designated "R-2A" and "R-2" on Zone Map Drawing No. C-407.1 , filed in the office of the City Clerk as Document No. 748501, be and it is hereby incorporated into R-2A and R-2 Zones as such zones are described and defined by Sections 101.0410 and 101.0409, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 78 (New Series), adopted November 14, 1932, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
