AN ORDINANCE AMENDING CHAPTER-II, ARTICLE 7, OF THE SAN DIEGO MUNICIPAL CODE BY ADDING SECTION 27.2204.1 RELATING TO THE ORDER OF LISTING OF CANDIDATES ON BALLOTS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 7, of the San Diego Municipal Code be, and the same is hereby amended by adding Section 27.2204.1 to read as follows:

SEC. 27.2204.1 LISTING OF CANDIDATES ON BALLOTS

Names of candidates as they shall be listed on
ballots shall be determined in the following manner:

a. At the Regular Municipal Primary Election of the Mayor or City Attorney, at any General Municipal Election for City office, or at any City-wide Special Election, the order of the names of candidates for Municipal office shall be rotated by Council District so that the first name listed on the ballot in District 1 shall be second in District 2 and the name listed last in District 1 shall be listed first in District 2 and then be second in District 3 and so on through all the districts. The order of the names as they shall be listed in District 1 shall be determined by the City Clerk by lot.

b. At any Regular Municipal Primary Election for Councilmanic Office, the order of names of candidates as they shall appear on the ballot shall be determined by the City Clerk by lot.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
