AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.1801 RELATING TO CITY DEPARTMENTS BY ADDING THE DEPARTMENT OF LEGISLATIVE ANALYST.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, Section 22.1801 of the San Diego Municipal Code be and the same is hereby amended to read as follows:

SEC. 22.1801 CITY DEPARTMENTS

- (a) Purpose and Intent. It is the purpose and intent of the City Council to enumerate the existing departments of the City because of repeated reference in City legislation and operation to such departments.
