AN ORDINANCE AMENDING ORDINANCE NO. 11331 (NEW SERIES), AS AMENDED, TO CREATE THE UNCLASSIFIED POSITION OF LEGISLATIVE ANALYST AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 11331 (New Series), as amended, of the ordinances of The City of San Diego, is hereby amended to create and establish in the Executive category the unclassified position of Legislative Analyst.

Section 2. As a schedule of compensation for the position created in Section 1 hereof, the following salary range of the Executive Salary Schedule established and adopted by Ordinance No. 11331 (New Series), as amended, of the ordinances of said City, is hereby adopted.
