

ORDINANCE NO. 11390
(New Series)

SEP 19 1974

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY LOCATED ON LOTS 10, 11 AND 12, BROOKLYN TERRACE SUBDIVISION, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 116 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That property in the Southeast San Diego Community located on Lots 10, 11 and 12, Brooklyn Terrace Subdivision, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-414.2, filed in the office of the City Clerk as Document No. 749251, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 116 (New Series), adopted January 3, 1933, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.


