AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY GENERALLY BOUNDED BY 51ST STREET ON THE WEST, HIGHWAY 94 ON THE NORTH, 56TH STREET ON THE EAST, AND THE R-4 ZONING TO THE NORTH OF MARKET STREET ON THE SOUTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-6 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 116 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HERewith.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Southeast San Diego Community generally bounded by 51st Street on the west, Highway 94 on the north, 56th Street on the east, and the R-4 zoning to the north of Market Street on the south, in the City of San Diego, California, within the boundary of the district designated "R-1-6" on Zone Map Drawing No. C-413.1, filed in the office of the City Clerk as Document No. 748314, be, and it is hereby incorporated into R-1-6 Zone as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.
