AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY LOCATED ON THE NORTH SIDE OF MARKET STREET AT THE INTERSECTION OF MARKET STREET AND UVAS STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 6259 (NEW SERIES), ADOPTED SEPTEMBER 21, 1954, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 2. That Ordinance No. 6259 (New Series), adopted September 21, 1954, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.
