AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY BOUNDED ON THE NORTH BY BROADWAY, ON THE WEST BY RADIO CANYON, ON THE SOUTH BY KENWOOD STREET, AND THE REAR LOT LINE BETWEEN WUNDERLIN AND BROOKLYN AVENUES, AND ON THE EAST BY 69TH STREET, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-6 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 116 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Southeast San Diego Community bounded on the north by Broadway, on the west by Radio Canyon, on the south by Kenwood Street, and the rear lot line between Wunderlin and Brooklyn Avenues, and on the east by 69th Street, in the City of San Diego, California, within the boundary of the district designated "R-1-6" on Zone Map Drawing No. C-414.2, filed in the office of the City Clerk as Document No. 749251, be, and it is hereby incorporated into R-1-6 Zone as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.
