AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY GENERALLY BOUNDED BY KENWOOD STREET ON THE SOUTH, RADIO DRIVE ON THE WEST, 1/2 BLOCK EAST OF IONA DRIVE ON THE EAST, AND 1/2 BLOCK NORTH OF BROOKLYN AVENUE ON THE NORTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-6 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 116 (NEW SERIES), ADOPTED JANUARY 3, 1933, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Southeast San Diego

Community generally bounded by Kenwood Street on the south,

Radio Drive on the west, 1/2 block east of Iona Drive on the
east, and 1/2 block north of Brooklyn Avenue on the north,
in the City of San Diego, California, within the boundary
of the district designated "R-1-6" on Zone Map Drawing

No. C-414.2 , filed in the office of the City Clerk as
Document No. 749251 , be, and it is hereby incorporated
into R-1-6 Zone as such zone is described and defined by
Section 101.0407 of the San Diego Municipal Code.
