AN ORDINANCE SETTING ASIDE AND DEDICATING A PORTION OF MIRA MESA VERDE UNIT NO. 11 IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "MESA VERDE PARK,"

WHEREAS, The City of San Diego is the owner of a portion of Mira Mesa Verde Unit No. 11 in the City of San Diego; and

WHEREAS, it is the desire of the people of the City of San Diego to set aside and dedicate forever said portion of Mira Mesa Verde Unit No. 11, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "Mesa Verde Park."

Section 3. That the real property so dedicated and named is described as follows:

Lot 1324 of Mira Mesa Verde Unit No. 11, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6701, filed in the office of the County Recorder of said San Diego County on August 11, 1970.
