AN ORDINANCE SETTING ASIDE AND DEDICATING A PORTION OF SECTION 26, TOWNSHIP 18 SOUTH, RANGE 2 WEST, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "SILVERWING PARK."

WHEREAS, The City of San Diego is the owner of a portion of Section 26, Township 18 South, Range 2 West, in the City of San Diego; and

WHEREAS, it is the desire of the people of the City of San Diego to set aside and dedicate forever said portion of Section 26, Township 18 South, Range 2 West, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "SILVERWING PARK."

Section 3. That the real property so dedicated and named is described in Exhibit A attached hereto and incorporated herein.
