AN ORDINANCE INCORPORATING PORTIONS OF LOTS A-205 AND A-206, OF ADDITION NO. 3 TO SAN YSIDRO, AND A PORTION OF NORTHEAST 1/4 OF THE NORTHEAST 1/4, SECTION 2, TOWNSHIP 19 SOUTH, RANGE 2 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-IP ZONE, AS DEFINED BY SECTION 101.0435.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10292 (NEW SERIES), ADOPTED MAY 5, 1970 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within two years of the effective date of this ordinance, portions of Lots A-205 and A-206, of Addition No. 3 to San Ysidro, and a portion of Northeast 1/4 of the Northeast 1/4, Section 2, Township 19 South, Range 2 West, S.B.B.M., in the City of San Diego, California, within the boundary of the district designated "M-IP" on Zone Map Drawing No. B-2805.1, are subdivided and a final subdivision map or maps thereof duly approved by the City Council and thereafter recorded and within such subdivision or subdivisions, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0435.1 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into M-IP Zone, as described by Section 101.0435.1, the boundary of such zone to be as indicated

on Zone Map Drawing No. B-2805.1, filed in the office of the City

Clerk as Document No. 748778

. Said zoning shall

attach only to those areas included in the subdivision map or maps
recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 10292 (New Series), adopted May 5, 1970, of the Ordinances of The City of San Diego be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
