ORDINANCE NO. 11409 OCT 1 7 1974

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE SOUTHEAST SAN DIEGO COMMUNITY LOCATED ON THE WEST SIDE OF 47TH STREET GENERALLY BETWEEN LOGAN AVENUE ON THE SOUTH AND FRANKLIN STREET ON THE NORTH, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2A ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 78 (NEW SERIES), ADOPTED NOVEMBER 14, 1932, OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as

Section 1. That property in the Southeast San Diego Community located on the west side of 47th Street generally between Logan Avenue on the south and Franklin Street on the north, in the City of San Diego, California, within the boundary of the district designated "R-2A" on Zone Map Drawing No. C-411.1, filed in the office of the City Clerk as Document No. 748316, be, and it is hereby incorporated into R-2A Zone as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 78 (New Series), adopted November 14, 1932, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
