ORDINANCE NO. 11413 (New Series)

AN ORDINANCE INCORPORATING THOSE PROPERTIES IN THE SOUTHEAST SAN DIEGO COMMUNITY LOCATED ON THE SOUTH SIDE OF FEDERAL BOULEVARD BETWEEN 60TH STREET ON THE WEST AND WINNETT STREET ON THE EAST, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-2 AND R-1-5 ZONES, AS DEFINED BY SECTIONS 101.0409 AND 101.0407, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9047 (NEW SERIES), ADOPTED JULY 9, 1964, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Those properties in the Southeast San Diego Community located on the south side of Federal Boulevard, between 60th Street on the west and Winnett Street on the east, in the City of San Diego, California, within the boundary of the districts designated "R-2" and "R-1-5" on Zone Map Drawing No. B-2793.2, filed in the office of the City Clerk as Document No. 749297 be, and they are hereby incorporated into R-2 and R-1-5 Zones as such zones are described and defined by Sections 101.0409 and 101.0407, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 9047 (New Series), adopted July 9, 1964, of the Ordinances of The City of San Diego, be, and the same is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
