WHEREAS, it is the desire of the people of The City of San
Diego to set aside and dedicate forever portions of said Pueblo
Lands, hereinafter described, for public use and enjoyment as and

purposes; NOW, THEREFORE,

Section 3. That the real property so dedicated and named is described in Exhibit A attached hereto and incorporated herein.
