AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN PORTIONS OF CLAIREMONT MANOR UNIT NO. 2 IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "NORTH CLAIREMONT COMMUNITY PARK."

WHEREAS, The City of San Diego is the owner of certain lands in Clairemont Manor Unit No. 2 in the City of San Diego; and

Diego to set aside and dedicate forever portions of said Clairemont

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "NORTH CLAIREMONT COMMUNITY PARK."

Section 3. That the real property so dedicated and named is described as follows:
