AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN PORTIONS OF LANDS IN THE OCEAN BEACH AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "OCEAN BEACH RECREATION CENTER."

WHEREAS, The City of San Diego is the owner of certain lands in the Ocean Beach area, in The City of San Diego; and

WHEREAS, it is the desire of the people of The City of San Diego to set aside and dedicate forever portions of said lands in the Ocean Beach area, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "OCEAN BEACH RECREATION CENTER."

Section 3. That the real property so dedicated and named is described as follows:

Lots 15 through 29, Block 31, Ocean Beach, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 279, filed in the office of said San Diego County Recorder on May 28, 1887.
