AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN PORTIONS OF PUEBLO LANDS IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "OLIVE GROVE COMMUNITY PARK."

WHEREAS, The City of San Diego is the owner of certain Pueblo Lands in the City of San Diego; and

WHEREAS, it is the desire of the people of The City of San Diego to set aside and dedicate forever portions of said Pueblo Lands, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "OLIVE GROVE COMMUNITY PARK."

Section 3. That the real property so dedicated and named is described in Exhibit A attached hereto and incorporated herein.

All that portion of Pueblo Lot 1231 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 36, bounded and described as follows:

Commencing at the Northeasterly corner of said Pueblo Lot 1231; thence North $89^{\circ}43'33''$ West, along the Northerly boundary of said Lot, 925.00 feet to the TRUE POINT OF BEGINNING; thence South $00^{\circ}01'15''$ West 643.80 feet; thence South $27^{\circ}19'27''$ West 198.97 feet; thence North $62^{\circ}40'33''$ West 705.00 feet; thence North $27^{\circ}19'27''$ East 561.85 feet to a point of intersection with the Northerly boundary of said Pueblo Lot 1231; thence South $89^{\circ}43'33''$ East, along said Northerly boundary, 460.00 feet returning to the TRUE POINT OF BEGINNING.

ORDINANCE NO. 1168

AN ORDINANCE SETTING ASIDE AND DEDICATING CERTAIN PORTIONS OF PUEBLO LANDS IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "OLIVE GROVE COMMUNITY PARK."

WHEREAS, The City of San Diego is the owner of certain Pueblo Lands in the City of San Diego; and

WHEREAS, it is the desire of the people of The City of San Diego to set aside and dedicate forever portions of said Pueblo Lands, hereinafter described, for public use and enjoyment as and for a public park to be used by all the public for park and recreational purposes; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the hereinafter described real property be and the same is hereby set aside and dedicated in perpetuity as a public park to be used by all the public for park and recreational purposes.

Section 2. That the hereinafter described real property be and the same is hereby named "OLIVE GROVE COMMUNITY PARK."

Section 3. That the real property so dedicated and named is described in Exhibit A attached hereto and incorporated herein.

Section 4. That the City Clerk of said City be and he is hereby authorized and directed to file and record in the office of the Recorder of San Diego County a certified copy of this ordinance.

Section 5. This ordinance shall take effect and be in force on the sixtieth day from and after its passage.

EXHIBIT A

PARCEL NO. 5 (Olive Grove Community Park)

All that portion of Pueblo Lot 1231 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to the Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 38, bounded and described as follows:

Commencing at the Northeastly corner of said Pueblo Lot 1231; thence North 89° 43' 33" West, along the Northerly boundary of said Lot, 925.00 feet to the TRUE POINT OF BEGINNING; thence South 00° 01' 15" West 443.80 feet; thence South 27° 19' 27" West 198.97 feet; thence North 82° 40' 33" West 705.00 feet; thence North 77° 19' 27" East 581.83 feet to a point of intersection with the Northerly boundary of said Pueblo Lot 1231; thence South 89° 43' 33" East, along said Northerly boundary, 450.00 feet returning to the TRUE POINT OF BEGINNING.

This parcel is bounded and described in Lot 5, Block 1, Subdivision No. 1, San Diego.
