AN ORDINANCE AMENDING ORDINANCE NO. 11348 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1974-75 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 746519, AS ADOPTED AND AMENDED THEREIN, RELATING TO THE POSITION AND SALARY SCHEDULE FOR THE LIBRARY DEPARTMENT, DEPARTMENT 20.00, FUND 100.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. - Intermediate Typist .375
- Junior Typist .375

Section 2. That the City Auditor and Comptroller be and he is hereby fully authorized and directed to transfer within the 100 Fund from the Unallocated Reserve (53.30) to the Library Department (Function 20.80) the sum of \$6,625 for the
