AN ORDINANCE AMENDING ORDINANCE NO. 11331 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1974-75," BY AMENDING EXHIBIT B THEREOF TO CREATE THE CLASSIFIED POSITION OF AIRPORTS MANAGER AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:




