

ORDINANCE NO. 11443

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA, LOCATED EAST OF MISSION GORGE ROAD, SOUTH OF ALLIED ROAD, WEST OF ARCHWOOD AVENUE, AND NORTH OF ZION AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10133 (NEW SERIES), ADOPTED AUGUST 28, 1969, AND ORDINANCE NO. 8920 (NEW SERIES), ADOPTED NOVEMBER 7, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THEY CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area, located east of Mission Gorge Road, south of Allied Road, west of Archwood Avenue, and north of Zion Avenue, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. C-427.1, filed in the office of the City Clerk as Document No. 749468, be, and it is hereby incorporated into R-3 Zone as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10133 (New Series), adopted August 28, 1969, and Ordinance No. 8920 (New Series), adopted November 7, 1963, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
