AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA, LOCATED EAST OF MISSION GORGE ROAD, SOUTH OF ALLIED ROAD, WEST OF ARCHWOOD AVENUE, AND NORTH OF ZION AVENUE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE, AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 101333 (NEW SERIES), ADOPTED AUGUST 28, 1969, AND ORDINANCE NO. 8920 (NEW SERIES), ADOPTED NOVEMBER 7, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THEY CONFLICT HEREWITH.

Section 2. That Ordinance No. 10133. (New Series), adopted August 28, 1969, and Ordinance No. 8920 (New Series), adopted November 7, 1963, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
