AN ORDINANCE ESTABLISHING A NEW
PARKING METER ZONE.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. Pursuant to the authority of Section 22508
of the California Vehicle Code, and in accordance with the
provisions of Chapter VIII of the San Diego Municipal Code, a
parking meter zone is hereby established in the following
locations:

East side of SECOND AVENUE, between Ash and
Beech Streets;

South side of BEECH STREET, between Second
and Third Avenues;

West side of THIRD AVENUE, between Beech and
Ash Streets; and

North side of ASH STREET, between Third and
Second Avenues.

The above-described meters shall be in parking meter Zone A as
described in Section 86.11 of the San Diego Municipal Code.

Section 2. A parking time limit of two hours shall be in
effect in the above-described locations between the hours of
8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted.

Section 3. The installation of parking meters and the
necessary signs and markings be, and the same are hereby
authorized to be made in the above-described locations.
