

ORDINANCE NO. 11462

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY AREA, LOCATED NORTHWEST OF WARING ROAD, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO THE R-1-40 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8769 (NEW SERIES), ADOPTED DECEMBER 27, 1962, AND ORDINANCE NO. 6488 (NEW SERIES), ADOPTED APRIL 1, 1955, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community Area, located northwest of Waring Road, in the City of San Diego, California, within the boundaries of the district designated "R-1-40" on Zone Map Drawing No. C-426.3, filed in the office of the City Clerk as Document No. 749641, be, and it is hereby incorporated into the R-1-40 Zone as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8769 (New Series), adopted December 27, 1962, and Ordinance No. 6488 (New Series), adopted April 1, 1955, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
