

ORDINANCE NO. 11463
(New Series)

DEC 26 1974

AN ORDINANCE INCORPORATING THAT PROPERTY IN THE NAVAJO COMMUNITY, LOCATED GENERALLY ADJACENT TO LAKE MURRAY, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO A-1-10 ZONE, AS DEFINED BY SECTION 101.0404, AND R-1-20 AND R-1-40 ZONES, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8335 (NEW SERIES), ADOPTED AUGUST 18, 1960, AND ORDINANCE NO. 4011 (NEW SERIES), ADOPTED MARCH 22, 1949, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That property in the Navajo Community, located generally adjacent to Lake Murray, in the City of San Diego, California, within the boundaries of the districts designated "A-1-10," "R-1-20" and "R-1-40" on Zone Map Drawing No. C-425.3, filed in the office of the City Clerk as Document No. 749743, be, and it is hereby incorporated into A-1-10 Zone, as such zone is described and defined by Section 101.0404, and R-1-20 and R-1-40 Zones, as such zones are described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 8335 (New Series), adopted August 18, 1960, and Ordinance No. 4011 (New Series), adopted March 22, 1949, of the Ordinances of The City of San Diego, be, and the same are hereby repealed insofar as they conflict herewith.
