

ORDINANCE NO. 11469
(New Series)

AN ORDINANCE INCORPORATING A PORTION OF LOTS 82-86, SAN YSIDRO, AND A PORTION OF STREET CLOSING, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA-S ZONE, AS DEFINED BY SECTION 101.0428 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8028 (NEW SERIES), ADOPTED DECEMBER 18, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map or maps for lot consolidation is recorded on a portion of Lots 82-86, San Ysidro, and a portion of street closing, in the City of San Diego, California, designated "CA-S" on Zone Map Drawing No. B-2813.2, the provisions of Section 101.0428 of the San Diego Municipal Code shall attach and become applicable to the said land and shall be incorporated into the CA-S Zone, as described by Section 101.0428, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2813.2, filed in the office of the City Clerk as Document No. 749313. Said zoning shall attach only to those areas included in the parcel map or maps recorded as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 8028 (New Series), adopted December 18, 1958, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
