
Adopted on DEC 20 1973

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City an agreement with KAWASAKI, THEILACKER & ASSOCIATES, a corporation, for landscape architectural services required for the design of the Point Loma Park and Recreation site, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 745873.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$16,000 is hereby authorized from Park and Recreation Bond Fund No. 725 solely and exclusively to provide funds for the above services and related expenses.
