WHEREAS, the Council of The City of San Diego has indicated its desire to establish an Educational Incentive Program for all sworn personnel in the San Diego Police Department; and

WHEREAS, funds for such program are available in the General Revenue Sharing Trust Accounts; and

WHEREAS, the Council directed its Management Team to meet and confer with representatives of the Police Officers Association in order to reach agreement on the program and execute a Memorandum of Understanding pursuant to such agreement; and

WHEREAS, the Management Team and representatives of the Police Officers Association have agreed upon the program and have executed a Memorandum of Understanding; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Memorandum of Understanding entered into between the Management Team and the Police Officers Association on December 20, 1973, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that there is hereby established an Educational Incentive Program for all sworn personnel in the San Diego Police Department pursuant to the terms and conditions of said Memorandum of Understanding on file in the Office of the City Clerk as Document No. 745972.
