Ernest M. Shaffer	PUBLIC WORKS DEPARTMENT Equipment Division	\$480	Mr. Shaffer is an Electrician Supervisor. State Industrial Safety Division orders require the City to change all (20) "bubble control" systems in sewerage pump stations. Mr. Shaffer designed circuits and parts to accomplish the requirements at a saving of \$4809 in material and labor from what the cost of the way in which the change would have been made if it were not for Mr. Shaffer's suggested design. In addition, there are substantial savings in servicing time that would have been required under the original plans for the change.
Daniel Karsh	POLICE DEPARTMENT	\$210	Some time ago Sgt. Karsh suggested a better system for notifying officers scheduled to appear in court that the appearance was called off or the time changed. This was done and Sgt. Karsh was awarded a Certificate of Merit. Experience with the system now shows that a saving of \$2100 per year has been made by the reduction in the number of overtime court appearances made unnecessarily.
