That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GEOCON, INCORPORATED, a California corporation, for soils engineering services in connection with design for reconstruction of the existing Atchison, Topeka & Santa Fe Railroad's overcrossing at Harbor Drive (PUC Crossing No. 2-268.9-A), under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 746005.

BE IT FURTHER RESOLVED, that the expenditure of \$1,150 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above referenced services, supplementing Resolution No. 208712 in this amount.
