
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$19,000, be and the same is hereby authorized from Park and Recreation Bond Fund No. 725, solely and exclusively for design, construction and related expenses in connection with the abovementioned agreement and services specified therein.
