That Change Order No. 1, dated December 13, 1973, heretofore filed with the City Clerk of said City as Document No. 746010 issued in connection with the contract between THE CITY OF SAN DIEGO and UNITED STATES ELEVATOR CORPORATION for installation of new passenger and freight elevators in the Fine Arts Gallery in Balboa Park, said contract having been filed as Document No. 208529 in the office of the City Clerk be, and the same is hereby approved; and the changes therein set forth, amounting to an increase in the contract price of \$6,000 be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$4,400 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above project, supplementing Resolution No. 208529 in this amount.
