


RESOLUTION No. 209605

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO and SAN DIEGO URBAN LEAGUE, INC., for the purpose of identifying 600 senior citizens who have not been reached by existing agencies due to their isolation, and to obtain and/or provide those goods or services which will improve their quality of life as part of the City-County program of using Revenue Sharing Funds for the operation of human care services as approved by Resolution No. 208955 on October 2, 1973, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 746018.
