That the City Manager be, and he is hereby authorized and empowered to accept, for and on behalf of said City, the transfer of \$111,011 from the joint City/County Revenue Sharing Trust Fund to General Fund 100 for the development and administration of (1) the Senior Citizens Job Development and Employment Program - \$53,000, and (2) the Centre City Senior Citizens Mobility Project -\$58,011 (\$21,567 City funds; \$36,444 County funds), both to be operated by the Human Resouces Department of The City of San Diego.
