
Adopted on JAN 1 5 1974

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$15,000.00, be and the same is hereby authorized from Park & Recreation Bond Fund No. 725, solely and exclusively for the purpose of providing funds for the above stated services and related expenses, and supplementing Resolution No. 208301 in this amount.
