That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement between City and VTN CONSOLIDATED, INC., for engineering services in connection with the design of Picador Boulevard improvements between Sunset Avenue and Del Sol Boulevard, including a railroad bridge overcrossing Picador Boulevard, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 746083; fees for said services not to exceed the sum of \$88,000.

BE IT FURTHER RESOLVED, that the expenditure of \$88,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the payment of fees to VTN CONSOLIDATED, INC. for said design and related expenses.
