
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of a sum not to exceed \$62,500.00, be and the same is hereby authorized from the Torrey Pines Golf Course Improvement Fund No. 248, and the expenditure of a sum not to exceed \$35,000.00, be and the same is hereby authorized from Capital Outlay Fund No. 245, solely and exclusively to provide funds for the construction of improvements to the Torrey Pines Golf Courses and related expenses, and supplementing Resolution No. 207713 in this amount.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary miscellaneous work related to the aforesaid improvements to the Torrey Pines Golf Courses, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
