WHEREAS, The State of California has offered three parcels of excess State Highway property, valued at \$502, adjacent to I-805 in the Clairemont area, to the City of San Diego to be used for public purposes; and

WHEREAS, the three parcels, comprising a total of approximately nine acres, are long, narrow, unbuildable strips of land; and

WHEREAS, the Community Development Department recognizes the need for bicycle paths in various areas of the City and recommends the acquisition of the property to be used for this public purpose; and

WHEREAS, funds are available in the Capital Outlay Fund 245, CIP 39-004 (4), Annual Allocation for the Acquisition of Miscellaneous Parcels of land; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the expenditure of \$502 from Capital Outlay Fund 245 for acquisition of three parcels of excess State Highway property, to be used for the above stated public purposes, be and the same is hereby authorized and approved.
