1. That the bid of \$129,650.00 by Card Construction Company, Inc., a corporation, for CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 193 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 745233.
2. That the expenditure of \$193,000 is hereby authorized out of Water Revenue Fund (Fund No. 502) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 193 in the City of San Diego, and related costs.
3. That the Environmental Impact Report No. 73-1-034C, dated June 11, 1973, filed in the office of the City Clerk be and the same is hereby adopted.
