


RESOLUTION No. 209665

Adopted on JAN 17 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$1,025,000.00, with a price adjustment on item 2 not to exceed 25%, such adjustment applying only to the price per ton of item 2 as it relates to price increases of the liquid asphalt, by West Con Construction Co. Inc., a corporation, for IMPROVEMENT OF BONITA COVE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 745389.
2. That the expenditure of \$1,115,000.00 is hereby authorized out of Park and Recreation Bond Fund (Fund No. 725) and that the expenditure of \$45,000.00 is hereby authorized out of Gas Tax Funds (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF BONITA COVE in the City of San Diego and related costs.
3. That the Environmental Impact Report No. 73-1-027C, dated June 13, 1973, filed in the office of the City Clerk be and the same is hereby adopted.
